Use of my services

When you sign up for one of my services, I ask you to provide personal information. This data is used to perform the service. The data is stored on Strado's secure servers. I will not combine this information with other personal data that I have available.

Communication

When you send e-mail or other messages to me, it is possible that I keep those messages. Sometimes I ask you for your personal details that are relevant to the situation in question. This makes it possible to process your questions and answer your requests. The data is stored on the provider Strado or that of a third party. I will not combine this information with other personal data that I have available.

Cookies

I collect data for research in order to gain a better insight into my customers, so that I can tailor my services accordingly. I do not share this information with third parties in any way.

This website uses "cookies" (text files placed on your computer) to help the website analyze how users use the site. The information generated by the cookie about your use of the website can be transferred to the provider Strado. I use this information to keep track of how you use the website, to compile reports on website activity and to offer other services relating to website activity and internet usage.

My website uses Google Analytics, a web analysis service offered by Google Inc. ("Google"). Google Analytics uses cookies that allow an analysis of the use of the website by you. The information collected by the cookie about your use of this website is usually sent to a Google server in the USA and stored there. If the IP anonymization is activated on

this website, your IP address will be shortened in advance by Google within member states of the European Union or in the other member states that are part of the European Economic Area. Only in exceptional cases will the full IP address be sent to a



Google server in the USA and shortened there. For the benefit of the website holder, Google will process this information to keep track of how you use the website, to compile reports on the website activities for the website holders and to offer other services with regard to website and internet use. The IP address sent by your browser in the context of Google Analytics is not linked to other data from Google. You can prevent cookies from being stored by selecting the appropriate settings in your browser. I would like to point out that in that case you may not be able to fully utilize all functions of this website.
